CITIZEN BAND POTAWATOMI INDIAN TRIBE OF OKLAHOMA

A RESOLUTION APPROVING A CLASS III GAMING COMPACT WITH THE STATE OF OKLAHOMA AND AUTHORIZING BUSINESS COMMITTEE CHAIRMAN, JOHN A. BARRETT, JR., TO EXECUTE SAME ON BEHALF OF THE TRIBE.

- the Citizen Band Potawatomi Indian Tribe of Oklahoma is a federally WHEREAS. recognized tribe of American Indians organized under authority of the Oklahoma Indian Welfare Act of 1936; and
- the Citizen Band Potawatomi Business Committee is duly authorized to act WHEREAS. on behalf of the Tribe by authority of the Tribal Constitution and By-Laws: and
- the Business Committee has the responsibility to create policy, establish WHEREAS, operational standards, and otherwise manage the daily affairs of tribal enterprises; and
- the Citizen Band Potawatomi currently operates Class II gaming in WHEREAS, facilities located within tribal Indian country; and
- Congress, through the Indian Gaming Regulatory Act, has authorized states WHEREAS, to negotiate Class III gaming compacts with Indian tribes; and
- the Citizen Band Potawatomi Business Committee has determined that said WHEREAS, gaming compact, a copy of which is attached, is necessary and in the Tribe's best interest:

THEREFORE, BE IT RESOLVED by the Business Committee of the Citizen Band Potawatomi Indian Tribe of Oklahoma that the attached Tribal-State Class III gaming compact is approved and the Chairman is hereby authorized to sign same on behalf of the Tribe and to do all things necessary and proper to acknowledge and effect the Tribe's approval of same. Further, the Tribal Secretary is directed to authenticate the Chairman's signature and capacity to sign said compact.
