Minutes of the last meeting were read and approved. Fill in the amount of \$5.25 to Helean Plumbing and Heating and approved. Reed George went over the changes, improvements and repairs that the plant itnagement recommended for improving and repairing the Community House, he also exhibited the plans drawn for the recommendations. Discussed also was the cost poving the community house across the road and onto the other piece of land, he cost of building a new community house. It was decided to check the st of building a new community house. Mr. Pecore and Mr. Madole gave a report on the Public Health Meeting held in klahoma City. The matter of those persons who enrolled after October 15, 1959, but who never rished affidavits, as requested by the business committee, saying that they s not adopted was discussed. Deputy Essistant Commissioner Finale's letter November 17, 1967, concerning the subject was discussed Also, the letter of October 26, 1966 from Assistant Secretary of the Interior Anderson concerning the N avarre family. The situations referred to in these two letters are similar. It was cointed out that there is apparent conflict in the intent of the letters. In. Mr. Anderson's letter the Tribe was upheld in removing the names of Keith Navarre, Nina Marie Navarre, Joyce Marie Navarre Brennan, Paul Gregory Brennan, Colleen Marie Brennan, Lisa Ann Brennan, and Francis Joseph Brennan from the roll because Keith Navarre and Joyce Marie Navarre B rennan could not provide evidence that they were not adopted. Their situation was similar to that of those persons who are referred to in resolution Pott-67-8. (It was pointed out that there are 43 persons in this situation and that the 21 referred to in the resolution was only an estimate made at the time.) Further discussion centered around Mr. Finale's letter. Mr. Finale states that "the band cannot reject applications for enrollment or exclude persons from sharing in the recent distribution if they meet the requirements for membership established by the constitution or amendments thereto metely because affidavits were not furnished.". That is the whole problem. The business committee cannot determine if they meet the requirements without an affidavit to the effect that they are not adopted. Birth certificates do not indicate whether or not they are adopted.

The secretary pointed out that some of these people had recently furnished the affidavits and that these were enrolled under resolution Pott-68-4. The secretary was instructed to identify these people and to take the necessary action to pay them in conformance with the above motion. In addition the secretary is to identify the rest of those who did not submit affidavits and write them a certified letter pointing out that when they furnish the affidavit they will get paid.

The withdrawing of the interest, from the 10% set aside for programing, in the United States Treasury to the credit of the band and placing it in local depositories to draw interest was discussed. It was decided to table this for further study.

Motion was made by Bernard Heer, second by Ennis Madole, that Resolution Pott-68-5, pertaining to members enrolling with the Tribe, be accepted. Motion passed with 4 voting for and none against.

The name of Mrs. Nora (Williams) O'Bennick was presented again for enrollment with further proof of her eligibility. Motion was made by Bernard Heer, second by Mary Alice Pecore that Nora (Williams) O'Bennick be enrolled and paid her share from the 1967 per capita distribution. Motion passed with 4 voting for and none against.

A quorum of members present the meeting was called to order at 7:45 PM. by the Chairman, in his home south of Shawnee. The meeting was called to select a site on which to build a new community house. Minustes of the last meeting were dispensed.

The plans and recommendations of the plant management were reviewed and discussed. After discussion of the amount of money that it would cost to repair and modernize the old community house it was decided that it would cost almost as much to repair the old community house as it would to build a new community house.

Billy Jim Burch made the motion to reject the plans submitted for remodeling and repairing the old community house. Second by Ennis Madole. Motion carried with voting for and none against.

There was a great deal of discussion about going ahead and building a new community house so it would be ready for use by the June Council Meeting. Mr. Heer objected to going ahead because he felt that the question should go before the Council for their vote.

Motion was made by Ennis Madole, second by Mary Alice Pecore, whether to go ahead and build a new community house, or not to go ahead and build a new community house. With 4 voting to go ahead and build, and 1 voting not to go ahead, by Bernard Heer, unless Council so decides, the motion carried.

Bernard Heer made the motion to limit the amount to be spent on building a new community house, including heating, air conditioning and everything. Motion was second by Billy Jim Burch. The motion carried with 4 voting for and 1 against, by Bernard Heer, unless Council so decides.

It was discussed as to the size the building should be and materials to use in the building, Ennis Madole made a motion to ask the Anadarko Office Plant Management to assist in drawing up the plans for a 30X50 foot building, and to supervise and inspect the building. The motion was second by Billy Jim Burch. The motion carried with 4 voting for and 1 against, by Bernard Heer, unless Council so decides.

After discussion as to where would be the best site to locate the Billy Jim Burch made the motion, second by Mary Alice Pecore, to a Anaderko Officia to help select the best location, or site, to locate the best location.

After discussion as to where would be the best site to locate the new building, Billy Jim Burch made the motion, second by Mary Alice Pecore, to ask the Anadarko Office to help select the best location, or site, to locate the new building on. Motion carried with \_4 voting for and \_1 against, by Bernard Heer, unless Council so decides.

After discussion as to what it would cost to build and furnish a new community house, Ennis Madole made the motion that a Resolution be written requesting that \$15000.00 be brought down from the United States Treasury to build and furnish a new community house. Motion was second by Billy Jim Burch. The motion carried with 4 voting for, and 1 against, by Bernard Heer, unless Council so decides. (It was later learned that this resolution could not be written without the consent of the Council.)

Mr. Pecore advised the committee that Joe Robinson had reported to him that an Education Program would be held in Norman the 24, 25, and 26th of July.



The Annual Council Meeting was called to order at 1:20 P.M., by the Chairman in the Potawatomi Community House, south of Shawnee, there being 125 members present.

Mr. Robert Seikel, Social Security Officer, gave a talk on social security and the benefits available under medicare.

Dr. Huskison, Indian Public Health Service, gave a talk on some of the new rulings and services abailable at the Shawnee Indian Clinic. The new hours effective beginning July 8, are Monday, Wednesday and Friday 8:00 A.M. til 4:30 P.M., Tuesday and Thursday 12:00 noon, til 8:00 P.M..

A motion was made by Priscilla Sherrard and seconded by Bessie Ridenhour that one nurse, one assistant laboratory technician, and one office girl be hired at the clinic. The motion carried. Resolution Pott-68-12.

Mr. Pecore introduced the members of the business committee and Mr. John Taylor, Superintendent; Joe Walker, Program Officers from the Shawnee Agency, and Bernhard Richert, Assistant Area Tribal Operations Officer from the Anadarko Area Office. Mr. Taylor distributed among the members a list of names of people for whom the Tribe still does not have a mailing address.

Minutes of the last meeting were read and approved. The financial report for fiscal years 1966-1967 and 1967-1968 were read by the treasurer and copies of the report distributed among the members.

There was a great deal of discussion about selling the land, and dissatisfaction about the amount of money that had been spent on bull dozing on the land.

Juanita Clifford made a motion to sell the land and houses, seconded by Charles Tade. With 25 voting for and 40 voting against, the motion did not pass.

Elva Wall made a motion that the vote on the previous motion be taken by written ballot from the entire membership. Motion seconded by Priscilla Sherrard. With 8 voting for, and 30 against, the motion did not pass.

Billy Jim Burch gave the report on the Community House. The cost to repair and modernize the present Community House would be \$6,500.00. The cost to build a new Community House would be \$20,000.00. Mrs. Mae Fairchild made the mo motion to let the present Community House set as it is, not to repair, and to leave the land as it is. Motion seconded by Grace Vietenheimer. With 55 voting for, and 1 against, the motion passed.

Page 2 - Minutes June 29, 1968

Motion was made by Priscilla Sherrard to build a new Community House, seconded by Thelma Shadden. With 7 voting for, and 40 against, the motion did not pass.

A motion was made by Juanita Clifford, seconded by Mary Lou Flynn, that mondy be used from the treasury to rent a place in town for the Council Meetings. With 50 voting for, and 4 voting against, the motion passed.

Charles Tade made a motion that all the principal and interest from the 10, per cent set aside from Docket 71-A that is being held in Washington, stay in Washington, and be paid out per capita with the next claim payment. Juanita Clifford seconded the motion. With 52 voting for, and 2 against, the motion passed. Resolution Pott-68-13.

Mr. Pecore ask if they didn't want to bring the \$41,000.00 interest down here and put in a local bank. Voting for 26, and against 10. Bess Ridenhour said she seconded the motion made by Priscella Sherrard, nowever, the legality of the motion was questioned by members. The motion contradicts the previous approved motion.

Meeting adjourned.

Billy Jim Burch suggested that the grievance committee be invited to attend the meeting with the tribal attorney the night before his report to the Council Meeting.

Motion was made by Bernard Heer, second by Mary Alice Pecore, that Mr. Steed be ask to present the appropriation bill and distribution bill, with \$25,000.00 set aside for business committee operating expense for the next 5 years. Motion carried, with 5 voting for and none against.

Bernard Heer made a motion, second by Ennis Madole, that the roll be closed as of January 1st, 196 9, for the distribution of Docket 96, and that \$25,000.00 be set aside for business committee operating expense for the next 5 years. (Later advised by Superintendent that it would be best to get passage of appropriation bill before presenting distribution bill and closing of roll. That January 1st,1969 might be premature date, and would be wiser to present distribution bill later and possibly include closing date of roll in the distribution bill.) The above motion carried, with 5 voting for and none against.
